

# Glen Allan School Council February 22, 2023 Administrator's Report

# Mid-Point Request for Feedback Survey Summary

- 12 families responded to the mid-point request for feedback
- The majority of respondents are aware of the school's three goals and have seen evidence of the work being done at Glen Allan related to them. The BE Paws have been well received.
- The majority of families read the Buzz messages and teacher newsletters and agendas. The school website is accessed to find information when needed. Mixed feedback from families wanting more information in the email and others wanting it simpler.
- Parents have been most engaged in their child's learning through:
  - Meet the teacher evening (100% of respondents attended) \*positive feedback related to hosting the evening prior to the first day of school
  - o Parent Teacher Conferences (100% of respondents attending)
  - Accessing Report Cards (100% of respondent)
- 100% of respondents indicated that they, or their child participated in school events
  - o Winter showcase feedback was positive for the most part. There was feedback related to visibility of the performers and one disappointed that we weren't at Park Church.
  - o Respondents requested a greater variety of hot lunch vendors
- Suggestions for growth moving forward:
  - o More out-of-school field trips for students
  - Frustration expressed with class sizes and composition and support in the classroom – funding issue

### **Assurance Surveys**

- Alberta Education Assurance Surveys are sent to parents with children in grade 4, 7 and 10. Students in these grades complete surveys along with all teachers. Our grade 4s be completed the survey last week. Deadline is March 1
- Additionally, EIPS will be conducting their own EIPS Annual Feedback Survey which is also data that is used in our Assurance Reviews. This survey will be administered to all staff, all parents in the Division and all grade 9 and 12 students. This survey will be administered on March 1-21. While it seems as though completing two surveys is redundant, the EIPS Survey more reliably reflects satisfaction as we are able to get a much higher response rate than Alberta Ed.

- Metis kit coming before spring break



# 2024-25 Fee Consultation Survey Summary


- 15 Respondents to the Fee Survey
- General consensus is families would like more field trips that are off school property.
- A comment was made indicating that noon supervisors are not hired with the noon supervision fee. At Glen Allan we do hire noon supervisors to supervise during the lunch hour and we also have Educational Assistants who work closely with specific students who also provide supervision at that time. Teachers do not do noon supervision.

Which of the follow statements reflects your perception of our current school fees for noon hour supervision?




Which of the follow statements reflects your perception of our current school fees for field trips? 15 responses





### School Fees Parameters

Fee Type	Parameter - All fees need to be set at cost recovery.				
Optional courses <sup>3</sup>	Fees can be increased up to 5%. Food courses will be allowed to increase up to 7%. Requires an explanation if exceeding this cap.				
Noon supervision <sup>1</sup>	Fees can be increased up to 5%. Requires an explanation if exceeding this cap.				
Activity fees (field trips) <sup>2</sup>	Fees can be increased up to 5%. Requires an explanation if exceeding this cap.				
Extra-curricular <sup>2</sup>	Fees can be increased up to 5%. Requires an explanation if exceeding this cap.				
Non-curricular travel <sup>2</sup> (overnight ski or band trips)	Fees can be increased up to 5%. Requires an explanation if exceeding this cap.				
Non-curricular goods and services (Student Union)	Fees can be increased up to 5%. Requires an explanation if exceeding this cap.

# **Proposed Fees**

- Increase in 5% of all field trip fees provides for more choice in out-of-school field trip experiences and to support increases in bussing and admission fees.
- Maintained noon supervision fees.
- Increased some extracurricular fees such as WISEST as their registration fee increased this year.
- Request support from GASC next year for bussing for one field trip per grade next year
- Proposed fees to be submitted for approval were shared (copy of draft fees included below)
- Feedback requested

<sup>&</sup>lt;sup>2</sup>last year schools were able to increase these fees at >5%. This cap at 5% incorporates some restriction. <sup>3</sup>food prices rose significantly in 2023 and this allows schools to "catch-up" in costs.
