1. Welcome and introductions

2. Approval of Sept 19, 2024 meeting minutes

- Erin Barrett motioned to approve, seconded by Jenn Campbell

3. School council updates (30 minutes)

- Chair Update - *Erin Hamilton*
 - Playground design feedback and next steps (November 1)
 - Top 5: Monkey bars, gliders, twirling/spinning things, swings, tube/covered slides
 - Need to do: share information with County to build out a design – wish list for November 1 (bid goes out from there; January/February will be proposal deadlines; build over the summer); Jen Ference went through data and had grades 5 and 6 students do surveys and drawings to share; need a group of approximately 4 parents to go through bids (possibly 2 GASC and 2 staff?); concerns around sand (alternatives are expensive); accessibility/inclusivity concerns – sand alternatives & accessibility could be GASC items to fundraise
 - Alberta School Council Engagement Grant
 - \$2000; \$500 for this year, \$1500 rolled over; numerous options for use; may not roll over beyond this year; need to look at ideas to use this
- Budget Vice-Chair update – *Erin Barrett*
 - 2024-25 budget presentation: ***Decision/vote required***
 - Yearbook reimbursement breaks even; budgeting more for family BBQ
 - Fundraising account doing well; art cards will come off; family dance to break even as not needed for fundraising (dependent on DJ costs); Read-a-thon based on previous years
 - Initial school disbursement request stays the same; surplus \$14K projected to remain
 - Gaming account: 50/50 license carries over into this year (focus to be busing for extra field trips)
 - Jenn Campbell to investigate casino date as 2 year frequency approaching

- Programs update – *Caitlin Burkholder, Vice Chair*
 - Yearbook cover update (lots of options, open to suggestions); order form to open earlier (end of hot lunch order) and run into November; Jen Ference to advertise through Buzz blog; use of Hot Lunch system only (contact GASC to arrange other orders); will have to be clear on orders to avoid late asks
 - Hot lunch site needed to be reset due to class issues

- Fund Development Committee Chair update – *Jenn Campbell*
 - Art cards – need to determine provider; possibly just scanning to be done via volunteers (3 volunteers possibly – converse about their thoughts, time commitment, etc) and sale of scans so families can do what they wish with those; art would need to come in before November break; initial scanning up to 5 full 8 hour days
 - Big fundraiser – Math-a-thon/Read-a-thon hybrid in the new year

4. Elk Island Public Schools (EIPS) Board of Trustees report (10 minutes) - *Trina Boymook*

A calendar survey has been sent out to parents/caregivers and staff to gather thoughts on 2 options. Survey closes October 21. The Board will make a decision at our December meeting.

Today a survey opened for the naming of the Sherwood Park replacement school. The survey is open to current and future parents, staff, students and members of the community. Survey is open until October 31. The Board will approve the name at our December Board meeting.

October 3 special Board meeting the board approved unallocated Capital Reserves in 2024-25 as follows:

- \$1,000,000 to the Salisbury Composite High Chiller project; and \$328,000 increase to the Voice over Internet Protocol (VoIP) project. Both of which are to be started and completed in the 2024-25 year.

At today's Board meeting the Board approved the following:

- Approved our modular request to the government which include GoA cover the cost to relocation of 6 modulars from West Hostford to Forst Saskatchewan and demolition of 2 Wesboro modulars.
- Trustee Shotbolt, Trustee for Fort Saskatchewan, served notice of resignation on October 7. Her last day on the board will be October 31. The Board has decided not to hold a byelection and have assigned her duties to the remaining of the Board. The Board will function with 7 Trustees until the general election next fall.
- Governance budget surplus of \$39,592 has been reallocated to leveraging student achievement funds bringing up a total of \$388K being available for the 2024-25 school year.

- The Board of Trustees direct the Superintendent to create a draft Administrative Procedure that outlines processes and guidelines for the accumulation, use and carry-over of school generated funds, to be brought to the January 9 Caucus Meeting for feedback.
